## **THE COACHING COMMITTEE**

**PURPOSE:** The Coaching Committee of the United States Adult Soccer Association (USASA) addresses coaching issues for the benefit of the USASA and the adult player.

### **COACHING COMMITTEE**

The coaching committee shall be responsible for—

- (1) Developing coaching programs addressing soccer education, ethics, safety, and risk management.
- (2) Establishing and maintaining a Coaching Program Informational Booklet for the membership to insure full understanding of the programs offered.
- (3) Reporting quarterly to the Executive Committee.
- (4) Working in cooperation with the Coaching Education Department of the US Soccer Federation (hereinafter “US Soccer”).
- (5) Propagating the program throughout the different organizational levels (Regions, National State Associations, Leagues, Clubs, and Players).
- (6) Helping the Regional coaches and USASA coaches establish a pool of players for the USASA teams.
- (7) Recommending to Regions, minimum coaching credentials, length of appointment and fees by the first regional meeting of the seasonal year.
- (8) Receiving and presenting applications along with recommendations for Regional Coaching appointments to the respective Regional Directors.
- (9) Receiving and presenting applications along with recommendations for USASA coaching appointments to the Executive Committee.
- (10) Establishing the criteria and participating in the selection of the four Regional coaches of the year and the USASA coach of the year awards.
- (11) Promoting Adult Council Coaching members and representing their views to US Soccer.
- (12) Encouraging coaches to promote participation in all USASA programs.

## **COACHING COMMITTEE COMPOSITION**

The Coaching Committee shall be composed of a Chairman, one representative from each of the four USASA Regions and a US Soccer Coaching Education Liaison. The Regional Directors of the respective USASA Regions appoint the four (4) Regional Coaching Committee members. The Chairman of the Committee is appointed by the USASA Chairman, subject to the approval of the Executive Committee.

## **USASA COACHING PROGRAMS**

**COACHING PROGRAMS:** The USASA offers two coaching education programs approved by US Soccer that are designed for the adult player. They are: the USASA Adult Coaching License and the Adult Coaching Certificate. These are US Soccer certified courses that offer training to the adult soccer membership.

### **USASA ADULT COACHING LICENSE**

Level I (Day 1). Consists of a classroom only presentation of coaching methods, team administration, care and prevention of injuries and the spirit of the laws. This is a great course for all those team administrators that just can't seem to get organized as well as any coach dealing with adult players. This course assists National State Associations in tailoring the course to help educate their membership in required administrative functions.

Level II (Day 2). Combines the classroom and field training in presenting methods of coaching, tactics theory, game analysis, technical training and tactical training. This portion of the course not only helps the new coach, or someone just making those substitutions, but also is recommended for coaches making the transition from working with youth to adult players.

Level III (Day 3). This course presents a continuation of the methods of coaching, tactics theory and technical training but also contains functional training, goalkeeping, practice coaching and a written final examination. We recommend any person coaching in the USASA to complete all three levels. With the successful completion of all three levels a coach may be eligible to take the National "C" course with the recommendation of their instructor.

### **USASA ADULT COACHING CERTIFICATE**

The Adult Coaching Certificate is specifically designed to elevate the level of coaching education within the USASA membership. It provides classroom and practical field coaching education. It is offered free of charge. It is purely educational and involves no testing. It will better prepare attendees to take the Adult License and other US Soccer coaching Licenses.

## USASA ADULT COACHING LICENSE

**PURPOSE AND PHILOSOPHY:** To train amateur coaches and team administrators in current coaching methodology, team administration and player preparation for all levels of Adult soccer. These coaching and team administration seminars will provide USASA coaches and team administrators the opportunity to discuss and be exposed to relevant topics targeted for their individual team and club needs. The courses may be hosted by the various National State Associations or the USASA. Instruction for this license can be provided by qualified licensed State, Regional, or USASA Staff Coaches selected by the National State Association or the USASA.

### PROGRAM DESCRIPTION:

#### **Level I (Day 1) is a 3-hr. course**

Methods of Coaching Soccer I	1hr.
Team Management	1hr.
Care & Prevention of Injuries	.5 hr.
Spirit of the Laws	.5 hr.

#### **Level II (Day 2) is an 8-hr. course**

Methods of Coaching Soccer II	1 hr.
Tactics Theory I	1 hr.
Reading The Game	1hr.
Technical Training I	1.5 hr.
Tactical Training I	1.5 hr.
Practice Coaching	2hrs

#### **Level III (Day 3) is a 9-hr. course**

Tactics Theory II	1 hr.
Technical Training II	1 hr.
Tactical Training II	1 hr.
Functional Training-Goalkeeper	1 hr.
Written Exam	1hr
Practical Coaching Exam	4hr

**Note:** Participants completing all three levels will receive US Adult Coaching Licensing through USSF. Completion of all three levels may serve as a waiver to the US Soccer National "C" License.

## USASA ADULT COACHING CERTIFICATE

**PURPOSE AND PHILOSOPHY:** To elevate the level of coaching education within the USASA membership. To make available practical and minimum coaching education that will better prepare coaches to coach their teams, take the Adult Coaching License and other coaching licenses. The course is intended to be purely educational and requires no testing.

### **Classroom:**

## HOW TO PUT ON THE ADULT COACHING LICENSE

Instruction for these seminars can be provided by State, Regional, USASA or USSF staff coaches, coaches holding an “A” license, and with the prior approval of the Chairman of the Coaching Committee, “B” licensed coaches. The National State Association sets the course fees. Items to keep in mind:

- 1) Obtain permission to put on the course from the Chairman of the Coaching Committee.
- 2) The USSF required fee of approximately \$15.00 each for the written material and for processing.
- 3) Your state association is responsible for the coaching instructor fee of \$25.00/hr.

Level I (3-hour course) = \$ 75.00 instructor fee  
Level II (8-hour course) = \$200.00 instructor fee  
Level III (9-hour course) = \$225.00 instructor fee

Total            \$500.00

- 4) The requesting state association is responsible for the coaching instructor travel expense and accommodations, when necessary.
- 5) You need to obtain appropriate facilities for the course with Level I requiring classroom only, while Levels II and III require both classroom and field space.
- 6) There is no minimum number of participants required for Level I courses but Levels II and III require a minimum of fifteen (15) participants when using staff coaches (Note: some exceptions can be made for State Associations just building a program or which have small numbers of players registered).
- 7) National State Associations can order the course material (workbooks) directly from the USSF National Coaching office at 1(800) 759-9636.
- 8) After the course is completed, the organizing State/Coaching Director will send the successful participant's Course Examination Report (name, address, date of birth, phone number, grades and date course completed) to the USASA Coaching committee Chairman.

## **How to Put the USASA Adult Coaching Certificate**

The curriculum for this Certificate is in the final drafting stage. We anticipate the course book being available in late 2003 or early 2004.

## **COACH OF THE YEAR AWARD**

**PURPOSE:** The USASA wishes to recognize the contribution coaches are making to the game and their role in the advancement of soccer. Each of the four regions will select a Regional Coach of the Year and from those individuals a USASA Coach of the Year will be selected. The Coaching Committee will introduce these coaches to the membership each year at the USASA Mid-Year Meeting at which time they will be presented a recognition award after which the USASA Coach of the Year Award will be presented. The USASA Administrator will arrange the travel and room accommodations of the selected coaches, as well as the awards selection and preparation.

**NOMINATION PROCESS:** Each National State Association may submit a candidate to their regional Coaching Committee member.

- 1) Each Coaching Committee Regional Representative will send out a letter (under USASA Coaching Committee letterhead) by September 15<sup>th</sup> to each National State Association requesting that they present their Coach of the Year nomination at the first Regional meeting of the USASA seasonal year.
- 2) The nomination must be submitted no later than the first Regional meeting of the USASA seasonal year.
- 3) At the Fall Regional meeting each National State Association shall submit a nominee for Coach of the Year.
- 4) Along with a letter from the National State Association submitting the candidate there must be submitted two (2) copies of the candidate's resume.
- 5) The Coaching Committee will select the Coach of the Year for each Region. The Coaching Committee Chairman will, in turn, submit the name of the selected candidates to the USASA Administrator.
- 6) The USASA Administrator will send written notification to the successful candidates to arrange their trip accommodations to the Mid-Year Meeting and copy their National State Association.
- 7) The Coaching Committee members will take the copies of the resume of their selected regional coach of the year and forward one copy to each of the other committee members to allow for the selection of the Coach of the Year for the USASA. Upon approval the Chairman of the Coaching Committee will submit the selection of the Coach of the Year to the USASA Administrator no later than December 15<sup>th</sup> of each seasonal year.

**THE BASIC CRITERIA USED FOR THE SELECTION OF THE REGIONAL AND USASA COACHES OF THE YEAR ARE AS FOLLOWS:**

- 1) The candidate must be a member of USASA.
- 2) The candidate must be active in coaching teams in USASA.
- 3) How much of the coach's time is spent in program(s) directly related to USASA.
- 4) Whether the candidate is active in more than one program in USASA, such as coach, player, administrator, referee, etc.
- 5) The candidate's impact on the program(s) in which the candidate is involved.
- 6) The level of coaching education achieved by the candidate.
- 7) Consistent winning and/or improvement of the team's performance under the candidate's coaching.

## **PROCEDURE FOR APPLYING FOR REGIONAL AND USASA COACHING POSITIONS**

**PURPOSE:** To allow for an uniform, organized and coordinated way for candidates to apply for the Regional and USASA coaching positions as they come open.

### **PROCEDURE FOR REGIONAL COACHING POSITION:**

When the position of Regional Coach becomes available, the Region Director will ask that the State Associations in their respective regions be notified of the opening and direct all applications to go through that region's Coaching Committee member and through the Coaching Committee Chairman.

- 1) Upon receipt of the application for an open coaching position the Coaching Committee member will forward copies of the applications and resumes to their Regional Director along with their recommendation for the position.
- 2) After inspection of the documents, should further information or clarification be needed, the respective Coaching Committee member will contact that individual to request the information needed.
- 3) The Regional Director will forward the nomination to the USASA Chairman for approval and announcement of appointment.

### **PROCEDURE FOR FILLING THE USASA NATIONAL COACHING POSITIONS:**

When the position of USASA coach becomes available the USASA Administrator will inform all National State Associations to submit their candidate's application through their respective regional Coaching Committee member.

- 1) Upon receipt of the application for an open coaching position, the Coaching Committee member will forward copies of the applications and resumes to the Coaching Committee Chairman and to the other members of the Coaching Committee.

- 2) After inspection of the documents by all members of the Committee, should further information or clarification be needed, the Coaching Committee Chairman will contact that individual to request the information needed.
- 3) The final decision of the committee will be forwarded to the USASA Chairman for final approval and announcement of appointment.

## **COACHING COMMITTEE PROCESS OF APPLICATION REVIEW AND SELECTION:**

- 1) The committee will solicit the advice of the following:
  - the person vacating the position as to a choice for a replacement;
  - the National team coaches as to who they would recommend for the position;
  - the USSF Director of Coaching;
  - the Region Directors;
  - the Select Team Committee Chairperson;
- 2) The Committee will review all applications and resumes.
- 3) The committee will invite those coaches they feel should apply and have not.
- 4) The Committee will attempt to select the best person for the job regardless of background or licensing qualifications. (Note: the Committee would expect any candidate that should be chosen that does not hold a USSF coaching license to complete the Adult coaching courses to a level III license and to endeavor to obtain a USSF coaching license.)
